#### **ELECTIONS AND INSTALLATIONS**

By now, all auxiliaries should have been elected. If you kept your same officer slate, actual installations were unnecessary. I hope you took advantage of having a joint installation with your Camp. Under elections, please be mindful that you should have elected your delegates. Automatic delegates for the Department Encampment are all sitting Auxiliary Presidents, all Past Auxiliary Presidents and all elected Department Officers. Each Auxiliary may also send two additional voting delegates to Department Encampment.

Automatic delegates for the National Encampment are all sitting Department Presidents, all Past Department Presidents, all Past National Presidents, all elected National Officers. Each Auxiliary may also send two voting delegates. (It is usually your Auxiliary President and one other.) The Ohio Department is permitted to send two voting delegates as well, which are elected at our June Encampment. If you need to have more clarification, this is addressed in out CR&R on the National website. If you have any questions, I am here to answer them.

It would be my pleasure to still visit your Auxiliary this year, this is your decision. The health and safety of my Sisters is my #1 priority.

I would ask each Auxiliary President to appoint one Sister as Department Aide who will assist the Department Chief of Staff in raising funds for the operation of the Department. Please relay that information and contact information to the Department Chief of Staff.

I would like to remind each Auxiliary Patriotic Instructor that in addition to the duties assigned in the Ritual you are also responsible for helping the Department Patriotic Instructor in raising funds for her work. One of the ways in which we keep alive the memory of the Union Veteran of the Civil War is through the donations made in their honor. The Auxiliary President or Secretary should supply the name and contact information to the Department Patriotic Instructor.
